The Board of Directors of the Hopewell Area School District conducted a virtual and in person Board meeting on Tuesday, January 14, 2025. This meeting was recorded.

The meeting was called to order at 7:17 p.m. by Dan Santia, Board President.

Discussion Item: Hopewell Area School Calendar 2025-26.

Dr. Beltz provided an overview of several proposed scenarios for the 2025-2026 school year calendar. Among the options presented was a scenario in which the school year would begin after the conclusion of the Hookstown Fair, reflecting community interest and accommodating a significant local tradition.

Dr. Beltz explained that the development of the calendar requires careful consideration of various factors, including the need to align with the schedules of students attending the Career and Technology Center (CTC) and New Horizon. He emphasized the importance of maintaining consistency between the District calendar and those institutions to ensure a seamless educational experience for students participating in those programs.

Board members discussed the potential implications of each proposed scenario, weighing the benefits of starting school after the fair against potential challenges. The Board acknowledged the complexity of balancing these considerations, but in the end, the Board agreed to adopt the scenario where the school year would begin after the conclusion of the Fair. Mr. Santia expressed his appreciation for the students who spoke on behalf of this initiative, commending their thoughtful and articulate advocacy for the change. The Board also acknowledged that this decision would be made on a yearly basis, allowing flexibility to adapt to future needs and circumstances.
